SCOPE OF WORK

Contractor shall provide cellular phone service for the U.S. Army Corps of Engineers, Philadelphia District for a period of performance of one (1) Base Year with two (2) Option Years in accordance with the attached scope of work. The Base Year period of performance will begin 1 February 2004 and end 31 January 2005. The Government may elect to exercise two one-year option periods after this, from 1 February 2005 to 31 January 2006 and 1 February 2006 to 31 January 2007.

Scope of Work for Philadelphia District's Cellular Service FY04

1. Provide Pooled Minutes Plan in National Coverage Area (approximately 25,000 minutes/month)
2. National Service for approximately 110 telephones
3. Provide free voice mail, caller ID, 3-way calling, paging, call forwarding and call waiting.
4. Provide consolidated billing
5. Provide free telephones and even swap of basic accessories (basic accessories should include car charger and carrying case).
6. Provide emergency service for up to 25 additional telephones for Emergency Operations Center when deemed necessary within a 24-hour period.
7. Replace phones if lost, damaged, etc.
8. Waive activation fee
9. No land line charges

10. Use of existing telephone numbers
11. Camera phone capability

Evaluation Factors:

This acquisition is based on the "Best Value" approach. The Philadelphia District intends to make an award to the responsible offeror, whose offer conforming to the solicitation will be the most advantageous to the Government. The Government, at its discretion, may award a contract on the basis of initial offers received, without discussions. Therefore, the initial proposal should contain the offeror's best terms from a technical and price standpoint.

Award will be based on technical factors and price. Contractor shall provide technical information on the following: quality of service to include timely technical assistance and coverage in our district area, number of minutes pooled under one contract, area of coverage, monthly access fee, use of existing telephone numbers, complete customer service to include no interruption of service for any reasons and complete customer satisfaction in case of equipment or service problems. Price will be given equal weight to the technical factors, when combined. The Government reserves the right to award based on a proposal that is not the lowest price.

CLAUSES INCORPORATED BY FULL TEXT

52.212-2 EVALUATION--COMMERCIAL ITEMS (JAN 1999)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Award will be based on technical factors and price. Contractor shall provide technical information on the following: quality of service to include timely technical assistance and coverage in our district area, number of minutes pooled under one contract, area of coverage, monthly access fee, use of existing telephone numbers, complete customer service to include no interruption of service for any reasons and complete customer satisfaction in case of equipment or service problems.

Price will be given equal weight to the technical factors, when combined. The Government reserves the right to award based on a proposal that is not the lowest price.

(b) Options. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.
